1. Review Agenda and Previous Meeting Minutes

2. Review 5 Year Report

- Ben Floyd presented important updates on the 5 year report progress for approval. (Please request presentation if you have not already received it).
- Alex Case Cohen had a question about page 12 of the presentation about the 89 water bodies quoted have improved. It was clarified by White Bluffs that they have not changed much.
- Levi Keesecker asked are all of these water bodies close or related to ag activities?
- Larry Cordes asked if we can identify the water bodies not improving so we could dedicate VSP efforts to those areas. It is unclear which bodies can be identified at this time but will look into this matter further.

- Indicators are hard to interpret and complicated and will have discussions about it moving forward in adaptive management. For now we are just focusing on whether or not the county is meeting its goals and benchmarks.
- Pend Oreille County met and or exceeded all 2021 benchmarks. No adaptive management is necessary in the 5 year report.

- Optimizing our Work Plan: adapting outreach/participation priorities. Reconsidering on the ground monitoring. Reassessing BMP/stewardship priorities.
- 5. Project proposal to pasture restoration project adjacent to WRP Grounds.
 - Total Cost estimate of \$5,996.00 but landowner would pay \$1,499.00
- 6. VSP Fiscal Year 2021 Budget Estimate
 - Funds available \$135,070.00.
 - Funds estimated to spend before ends is just about \$64,000
 - Total Cost share projects amount to \$54,790.00
 - Total cost share project funds remaining \$50,996
 - 13 projects total, 12 are still incomplete but in process to completion before June 1
 - After expenses, staff time and cost share allocations we have a balance of \$19,543 leftover.
